SF & GH suggested that the next round (Round 2) of the EA grants could be promoted through the local media. CP mentioned that wind energy reached a new first with 43% of energy consumed in SA coming from wind energy. GH mentioned that the media in recent days has been focussed on the RET (Renewable Energy Target) and potential change in policy by the Federal Government and what this means for wind energy going forward. It is important to note that only the first year has been approved at this stage. The grant will create opportunities to begin mapping of the focus area. Once mapping is complete, a steering committee can be formed to study the mapping and decide on priority areas. AR advised that involvement with landowners is important in the first year as it will help the project gain traction. GH asked if there were any comments or questions regarding the minutes? No comments were raised by the members. Members accepted the 8 May 2014 Minutes as a true representation of the meeting.

3.1	Waterloo Wind Farm Update	
	MC provided an update on Waterloo Wind Farm.	
	 Energy Production Figures July 2013 through to June 2014: 	
	 Generation for the month of June resulted in +47.94% against the planned target. 	
	 Waterloo generation for the financial year 2013/2014 was 335.42 GWh against a Target of 308.69 GWh, resulting in +8.7% trend against the set Year to Date Target. 	
	 A CLG member raised a query as to whether 8.7% is a good increase? 	
	 EnergyAustralia responded by stating that the board are very happy with the results and added that it is a considerable amount of energy that has been produced. CP added that the targets are not set to be easily achieved. 	
	Energy Production Figures July 2014 / June 2015:	
	 Favourable wind conditions during July 2014 resulted in a capacity factor of 53.56% (target 39.68%) and a new monthly record Net Generation of 43.58 GWh (target 32.52 GWh). 	
	 Financial Year to Date Net production is tracking at +34.2% against plan. 	
	o CH questioned what EnergyAustralia's target is for this financial year.	
	o CP stated that the target is for 330 GWh.	
	Site Operations / Maintenance has been pretty much business as usual.	
	MC stated that EnergyAustralia are currently undertaking the following reviews:	
	o Revision of the Environmental policy.	
	 Review of the Environmental aspects and impacts register. 	
	 Review of site Environmental training needs analysis. 	
	 As part of the EnergyAustralia sponsorship of Port Adelaide Football Club, three players, including the captain, visited Waterloo Wind Farm on the 22 July 2014. There was a good turn out by the local community (including one of the landowner's, who is a Port Adelaide fan).

3.2	Proposed Waterloo 2 Wind Farm Update	
	CP provided an update on the Waterloo 2 Wind Farm Development.	
	 CP advised that EnergyAustralia are currently waiting for a review to be completed. Whilst the progress is unsure at the moment, the Renewable Energy Target (RET) will be fundamental to the progress of the Waterloo 2 project. 	
	 A CLG member raised that the media has recently stated that wind & solar employ more people than the coal industry. 	
	 CP responded by stating that certain projects are quite labour intensive (such as the solar industry) where most jobs are within the construction / installation stages. 	
	 A CLG member raised the issue of whether the Waterloo 2 progress was held up politically given the Federal Government's debate on the RET. 	
	 CP stated that the RET is one of the factors that is affecting decision making. 	
	 A follow-on question was raised as to whether the Waterloo 2 project would have been completed if it was at this stage before the election? 	
	 CP stated that the market determines what is viable. 	
3.3	Proposed Stony Gap Wind Farm Update	
	CP provided an update on the Stony Gap Wind Farm Development Application.	
	 CP advised that EnergyAustralia has not yet received a decision from the ERD Court. There is no mandated timeframe for the ERD Court to respond. CP added that the process is quite time consuming, in that the Court needs to read through the transcripts from the hearing, then prepare a narrative with the decision. This can take approximately 6-8 weeks for a simple case; however, as the Stony Gap hearing was complicated, it is expected to take more time. 	
	 A CLG member asked whether EnergyAustralia were pleased with the hearing. 	
	 CP stated that EA had put forward a professional case with strong arguments and strong expert witness statements. Overall EA were pleased with the hearing. The key grounds of opposition included:

	 As the Appellant, EnergyAustralia was required to demonstrate the planning merit of the revised project, notwithstanding the development process to date, and produce expert witness evidence to support its application. 	
	Key Points of opposition discussion clearly focused on the topics of noise and health.	
	 GH asked the CLG members if they would be interested in receiving a link to the ERD Court's determination, once handed down. CLG members said that would be of interest. 	
	GH asked members if they had heard much discussion in the broader community about the Stony Gap proposed development and appeal.	
	 The CLG had not heard any discussions within the community. It is likely that more discussion will be heard once a decision has been made.

	 The lizards occupy native grasslands which are located on hillsides that may be difficult to farm. 	
	 Surveys and studies since 1992 have established significant information about their burrows, predation, reproduction, behaviour, distribution, habitat and threats. 	
	The lizards are prone to three main threats: fire, predation and development.	
	 Research is now looking into ways to enhance, manage and monitor lizard populations, including translocation strategies. 	
	 A CLG member asked how long the lizards are. 	
	 Michael stated that they are approximately 10cm in length. 	
	 A CLG member asked what their life expectancy is. 	
	 Michael advised that it is approximately 20 years. 	
	 A CLG member asked how long they take to reach maturity.
