Draft Wollongong Local Environmental Plan

Wollongong Council is exhibiting its draft Local Environmental Plan (DLEP), which provides the framework for all future development at Tallawarra. We encourage you to view the plan and share your thoughts. Council is receiving submissions up to 13 March 2009.

What the LEP means for Tallawarra

The new LEP updates the land zonings for Tallawarra. Some of the potential benefits: -

- More area for environmental/ recreational purposes. The "green" zoned areas increase by an area the size of 125 soccer fields.
- Employment land to accommodate a future labour force.
- Land to help satisfy the growing region's housing needs.
