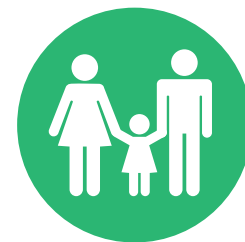

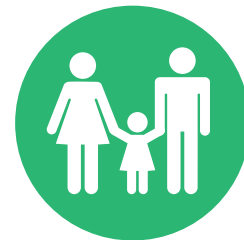

1. Be a NSW resident, AND
2. Have been assessed by the Federal Department of Human Services (DHS) as being eligible for the Family Tax Benefit (FTB) A or B at any time during the 2013-2014 financial year, and, have received an FTB payment in respect of that eligibility; AND
3. Be an account holder of an electricity retailer, or, a long-term resident of a residential community (caravan or mobile home park), whose name appears on the electricity account for supply to her or his principal place of residence.
